

# **SELF PROTECTION AND PRESERVATION STRATEGIES**

## 1. GENERAL

- a) Own nothing, control everything, whether its you home, investment property, gold & silver, business, car's. NEVER own anything
- b) PRESERVE your privacy. NEVER give your real home address to anyone electronically or over the phone. NEVER disclose it to the parasites, pirates & plunderers. If people want to meet you (other than close personal friends) they can meet you at your nominated neutral business such as a coffee shop.
- c) Don't speak with or conduct business with anyone you DON'T wish or consent to. Contract Law prevails. Anyone approaching you wanting something is approaching you with an OFFER, no matter whether it be in writing, no matter what the paperwork is, or oral; it's an OFFER!  
There is NO LAW that compels you to accept someone's OFFER, you don't have to ACCEPT the offerer's offer UNLESS you are already under arrest. CONTRACT LAW prevails – OFFER & ACCEPTANCE. So if you accept the offer's paperwork or the offerer's oral statement, eg. They offer to you that you must come with them to the police station for questioning, you can say 'NO, I don't accept nor consent as is my inherent right, doesn't contract law prevail?'. Now there is no contract & the offerer cannot force you to go with them. Force or coercion invalidates any contract because by definition contracts are entered by mutual CONSENT. They are VOLUNTARY! GOT IT?

## 2. APPROACHED ON THE ROAD

Strategy:

- a) Ensure you have the following documents on hand;
  - i) – Notice of Conditional Acceptance, which is an offer to contract which the officer needs to sign thereby taking liability for breaking the law. They won't sign & will let you go free
  - ii) - Source document, the document that mother completed & signed that 'gave rise to' the Birth Certificate. The source document (Victoria & NSW – called the 'application for registration of birth', for Queensland 'Certificate of Birth') and the state & federal police, any member of the public for that matter, have no control over the 'holder' (you) of the source document! It is evidence YOU are the 'soveran' & cannot be compelled to be ordered by anyone what to do. You can simply say 'NO, I don't accept your offer to contract with me nor do I consent'.

- iii) Ensure your 'PRIVATE PROPERTY NOTICE' car label is on the dashboard so any parasite or pirate is NOTICED that the car is private property & used for private purposes so that anyone tampering with it is doing so illegally & under their own commercial liability. The car or bike will be left alone!
- b) Ensure you keep an audio visual recorder (your mobile phone) with you to record any attempt by anyone to solicit from you without your consent. Recording the encounter CREATES the EVIDENCE for your freedom & victory. Parasites & pirates grossly dislike having their plundering activities recorded & uploaded to 'Youtube'. PROTECT yourself!
- c) Ensure you know how to articulate your response to any approach from anyone representing a parasitic pirate or plunderer. Remember - Contract Law prevails *see '1(c) above*.  
 To approach you on the road or anywhere else, a police officer or any other claimant MUST have reasonable cause. No-one has authority or jurisdiction to simply target you. You are NEVER compelled to conduct business with anyone (the Police Service of your state being a corporation, operating under contract law conditions & therefore 'soliciting' your business) you choose not to UNLESS you are already under arrest. Otherwise you are free to go about your business without any limitations or obstructions by anyone. There is Victorian & NSW case law disclosing that no-one is compelled to conduct business with the police UNLESS they are under arrest. Where you under arrest when directed to pull to the side of the road? NO! So 'Hold Your Position' & once accomplished, continue your journey! ### 3. APPROACHED AT HOME

Strategy:

Much the same as '2' above.

Instead of using a 'PRIVATE PROPERTY NOTICE' for a car or any other moving item, you will have put up three 'TRESSPASS NOTICES', one on the front gate, any point between the gate & front door & the 3<sup>rd</sup> on the front door. Three Notices & OUT! Has been successfully used many times.

Justice Kirby in a landmark decision in the High Court in 1998 declared that 'NO-ONE, not even the Queen could trespass your property WITHOUT a Crown warrant'. Crown warrants haven't been issued for decades.

An additional documents to keep at your finger tips is an 'Affidavit of Claimant' which you pass to any intruder – trespasser with directions to complete before

entering further & you can NOTICE them they have trespassed & if they don't remove themselves forthwith, you will pursue charges against them. Most often, even the most hardened parasitic pirates, with draw. They know what a High Court decision is & they understand 'trespass' if properly presented by you.

Note: This is only for folks that already have inherent integrity & recognize personal responsibility & accountability & know who they are (people and NOT persons, look up the legal definitions of 'person').
